Raymond to come the break room in the tower of the Detention Center. I asked Cpl. Raymond if he had any issues towards Jailer King and he said no not anymore it has been taken care of. I asked Jailer King if this issue has been taken care of and she said yes. I told both Cpl. Raymond and Jailer King to be professional towards each other and both said yes.

At approximately 11:30 a.m. on 8-17-2019 I, Corporal Ethan Raymond, was up in the tower along with Jailers Radcliff and Johnson. Jailer King completed a female check and was on her way back to the tower when I told her to go ahead and do pill call. Jailer King then yelled that she didn't want to do it and gave no reason why. I then ordered her to pass out medications while she was down there in which she complied.

Jailer King then turned music on her phone and began pill call starting with A-Pod. At or about this time I overheard Inmate Steven Niziol say "What are you gunna do? Call for backup" then I heard Jailer King say "No, they wouldn't have my fucking back anyway". I then looked up at the camera for A-Pod door and observed Inmate Niziol standing by the medical cart and heard Jailer King Say "Last call Pill Call" then shut the door and continued onto B-Pod. I then called down to Jailer King to stop playing music from her phone in which she did not hear me.

After the completion of pill call Jailer King entered the tower and slammed both the bathroom door and the top door to the tower. I then told Jailer King not to slam doors and left the tower. Approximately 30 minutes later Jailer King called me at the booking phone and advised that she needed to speak with me. I asked what it was about and she said that I needed to come up to the Tower.

When I entered the Tower I walked over to Jailer King and asked what's going on and she got up and told me to follow her to the back so we could talk. I followed her to the kitchen area where she turned around and yelled at me "I want off your fucking shift" I asked why and she yelled again that "That we didn't have her back". This is when I told her to stop yelling at me and asked her what had happened for her to feel this way and she advised me that Inmate Niziol grabbed her breast during pill call. I told her that she needs to make a report on the incident and charge him for touching her.

I asked Jailer King why she did not notify anyone when it happened and why she waited so long to tell us. Jailer King did not answer my questions and continued to yell at me. I told Jailer King that she needs to speak to Sgt. Beck if she has problems with me and wants to change shifts. I then walked back into the Tower followed by Jailer King and told her again that Sgt. Beck was currently in booking and that she needs to go talk to him. She then sat down in a chair and refused to go speak to him and continued to yell at me. I told her multiple times that she needs to go speak with him now while he is here and I could not be the one

to help her with moving shifts. She then got up and walked into the stairwell and stayed in there for approximately 5 minutes and return to the tower and said that she doesn't have to listen or talk to either Sgt. Beck or myself. She went on to state that she just got down talking to Lt. Lewis and that he will take care of it.

I left the tower and went down to booking and asked Sgt. Beck if I could speak with for a moment. We then went outside were I informed him of the incident that happened at pill call and what had happened in to tower between me and Jailer King.
