Ms. Jones,

There is not an official report or letter from the State Fire Marshal's Office. We were only on site to assist the Mountain Home Fire Marshal with code question and advisement. I spoke with Tim Cain a few days ago and inform him that from information on the dates of when the Big Top was installed over the existing buildings and the buildings being connected, the square footage of the structures may have increased to over 15,000 square feet, which at that time the building were required to have fire sprinklers installed. As for the building being unsafe for students and staff, we did not notice any concerns. The addition of the Big Top does provide a added hazard for fire fighters. The structural report from the engineers states that the structure cannot withstand any additional weight such as sprinkler system.
