Both Lake county and Sangamon county’s crimes were committed simultaneously as the crimes committed in McHenry. There is a ten year gap in crimes solely because Steven Manson (along with his father) was sentenced to 20 year sentences in the IDOC.

If you look at the cases, he was court ordered to pay fines – he has failed to do so. That means that as a victim of his crimes – I am once again being victimized and forced to pay for his abhorrent behavior, not only through the processing of his crimes – but now through his court system abuses and stalling tactics.
